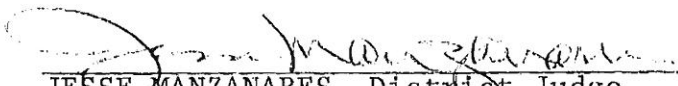

COMES NOW Petitioners and hereby represent to the Court
as follows:

1. This is a Petition filed pursuant to C.R.S. ³¹31-1-101
et. seq. for the formation of a special district and more
specifically C.R.S. 31-1-301.

2. That the type of service to be provided by the proposed
special district is an ambulance service which would provide
for the treatment and transportation of the sick, injured or
otherwise incapacitated or helpless.

3. That the proposed special district shall be known as
the Trinidad Ambulance District.

4. That there will not be any facilities or improvements
constructed, installed, or purchased for the special district.

5. That the proposed special district does not lie wholly
or partially within another special district.

6. That proposed special district does lie entirely within
the City of Trinidad, Colorado, a municipality.

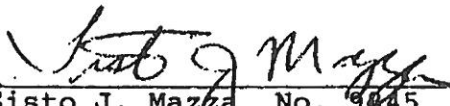
7. That the estimated property tax revenues for the
district's first budget year is \$60,000.00.

8. That the boundaries of the special district will be
the exact same boundaries as the municipal boundaries of the
City of Trinidad, Colorado.

9. That attached hereto is a certified copy of a resolution
adopted and passed by the Trinidad City Council on March 1,
1988, approving the service plan submitted by Petitioners for
the formation of the special district.

Wherefore, Petitioners request that said special district
be organized.
